

Minutes of the Meeting of the Board of Directors of SMCWD

November 21, 2023

The Board of Directors of the SMCWD met in regular session on Tuesday, November 21, 2023, at 5444 Alta Monte Drive in Santa Rosa, Sonoma County, California. The meeting was called to order at 3:22 p.m. by the President of the Board of Directors, Tom Cronin.

Superintendent's Report:

Director Cowley reported that there was a clogged service line on Alta Monte. He contacted Gromala Bros who came out and dug up the driveway to locate service line, unclogged and flushed it. They installed a new traffic rated box in the driveway so the line could be more easily accessed in the future.

Our customer at 2055 Aberdeen contacted the district to report a leak on our side of his meter. Operator Hansen and Director Cowley found a leak at the union. There were a lot of tree roots causing an issue with reconnecting everything. The customer decided to have his son-in-law run a new line from the meter to the house.

General Manager's Report:

The financial documents for the two months (September and October) were delivered with the agenda to all directors. Director Christensen reviewed the bank statements and initialed them.

New Business:

The customers at 5525 Inverness requested SMCWD buy a new meter box and place it over their meter. M/s/c Directors Cowley/Christensen to purchase a new meter box for an amount not to exceed \$200.

After the service line was unclogged on Alta Monte, the customer realized he had a leak at his tank. A joint came apart and he requested a leak adjustment.
