Director Cowley reported that all the lines were flushed. The water cleared up really fast. He believes it is due to the tanks being cleaned.

The fire hydrant at the bottom of Inverness is getting covered with dirt from above it.

The reimbursement from Parks Electric is still pending. Parks Electric has filed a claim with his insurance company.

General Manager's Report:

The financials for (January and February) were sent with the agenda. Director Christensen reviewed the bank statements prior to the meeting and initialed them at the meeting.

The GM reported that her computer is old and starting to malfunction at times. She added the Sage software to her laptop as a backup in case the computer crashes. There is a possibility that new software will need to be purchased. VP Christensen will contact an associate CPA to get their opinion on Sage vs Quickbooks and desktop version vs online version. The current software was purchased in 2019 as a desktop version for \$322.35.
